- 1. Financial Bids in respect of all the five Packages viz. 1/5, 2/5, 3/5, 4/5 and 5/5 were decrypted one by one. Bidders present were given the opportunity of viewing the Financial Bid opening through projection in real time.
- 2. Financial Bids for Package-1 (1/5) was opened first in terms of ITB 35.1. Rates quoted by the bidders were as follows:-

6. Financial Bids for Package-5 (5/5) was opened thereafter. Rates quoted by the bidders were as follows:-

- 7. Hero Cycles Ltd. was found to be the L1 bidder for Packages 1/5 and 2/5 and thus was declared as the Selected Bidder for the said packages. Avon Cycles Ltd. and Tube Investments of India Ltd. being the L1 bidders in Packages 3/5 and 4/5 respectively, were also declared as the Selected Bidders for the said packages.
- 8. In Package 5/5, as both Avon Cycles Ltd. and Tube Investments of India Ltd. were tie-bidders in terms of ITB 35.2, the Committee decided to split the package between the tie-bidders in terms of sub-clause (b) of ITB 35.2. Avon Cycles Ltd. was directed in terms of ITB 35.1, to match its lowest price across all packages, viz. the L1 price of Rs. 3,312/- for supplying half of the bicycles required to be supplied under Package 5/5, i.e., 2,50,000 bicycles and Avon Cycles Ltd. agreed to match such lowest price. Since the L1 price in Package 5/5 had come down to Rs. 3,312/-, Tube Investments of India Ltd., also agreed to match the price of Rs. 3,312/- for supplying the remaining 2,50,000 bicycles in Package 5/5.
- 9. Since the finally settled financial bid of Rs. 3,312/- in Package 5/5 quoted by Tube Investments of India Ltd. became its L1 price, the Committee directed Tube Investments of India Ltd. to lower the price quoted in Package 4/5 and match the price

of Rs. 3,312/- quoted in Package 5/5 and Tube Investments of India Ltd. agreed to such proposal.

- 10. System generated BOQ chart (comparative statement of rates) in respect of all the four packages were signed by the bidders as well as by the members of the Tender Committee.
- 11. The meeting ended with a thanks to and from the chair.
