Minutes of meeting of the inter-Departmental Tender Committee for Procurement of 15 lakh bicycles under Sabooj Sathi Phase-VIII

As per the Bidding Schedule, pre-bid meeting was held with the representatives of prospective bidders (list attached) on Friday, 28th October, 2022 at 3 P.M.

- 1. One of the prospective bidders, Motovolt Mobility Pvt. Ltd., intending to bid under Section VII of the Bidding Documents sought the following relaxations in the bidding criteria:
 - (a) Allowing bidding by consortium/ joint venture formed by manufacturers
 - (b) Considering Net Worth as a parameter for new local manufacturers, instead of turnover criteria
 - (c) Relaxation of criteria of actual manufacture of bicycles, to encourage local participation
- 2. It was informed that the pre-qualification criteria have already been relaxed and incorporated in the Bid document for 2nd call of the Ref. No. 900/SCTB, dated 15/09/2022. The committee considered the specific relaxations further sought by the prospective bidder and decided that further relaxation is not acceptable. The representation of the prospective bidder may be brought to the notice of the State Government for consideration.
- 3. It was clarified that EMDs submitted online in the 1st call shall automatically be credited to bidder's respective account in the reverse root on cancellation of 1st call. For 2nd call EMD is to be paid afresh online. For local Manufacturers, EMD is to be submitted offline and the receipt is to be uploaded.
- 4. It was re-iterated on verbal enquiry from the prospective bidders under Section –VII that they have to submit technical bid only.
- 5. A question was raised regarding price preference for local manufacturers. It was clarified that 15% price preference is allowed for those bidding under MSME category and that clause is not applicable for those bidding under local manufacturer category. Those bidding under local manufacturer category need not submit financial bid.
- 6. No other suggestion was received from the prospective bidders.
- 7. The Committee emphasized strict compliance by the prospective bidders of the Bidding Schedule as contained in the Bidding Documents.
- 8. The Committee further decided that the resolution of the pre-bid meeting be uploaded in the e-tender portal of Govt. of West Bengal, Saboojsathi portal & official portal of WB SC ST & OBC Development and Finance Corporation.
