1. As per the Bidding Schedule, pre-bid meeting was held with the representatives of prospective bidders (list attached) on Wednesday, 23<sup>rd</sup> October, 2024 at 4 P.M.
2. The prospective bidders stated that they needed no further clarification with respect to the Bidding Documents.
3. Unirox Bikes Pvt Ltd proposed to do away with the requirement of credentials relating to technical capacity requirements for last 3 years for MSMEs as those appears to be restrictive for new MSME bidders planning to start manufacturing in West Bengal. However, he informed that he will apply as local manufacturer under the Preferential Purchase Policy of the State Govt as per clause 17 of e-NIT after discovery of rate.
4. The Committee decided that no modification with regard to clauses pertaining to MSEs will be made as those were framed in tune with Order No. 10500-F, Dated-19/11/2004 of Finance Department. The Committee emphasized the strict compliance by the prospective bidders of the Bidding Schedule as contained in the Bidding Documents.
5. The Committee further decided that the resolution of the pre-bid meeting may be uploaded in the official portals of the Corporation and Sabooj Sathi as well.
