- 5. The rate of Rs. 4,019/- offered by Hero Ecotech Ltd. across all the 3 Packages was the lowest Financial Bid offered and hence declared to be the L1 rate. Hero Ecotech Ltd. was found to be the L1 bidder for Package 1/3 and thus was declared as the Selected Bidder for the said package.
- 6. In Package 2/3, in terms of ITB 35.1, although Hero Ecotech Ltd. was the L1 bidder with a Financial Bid of Rs. 4,019/-, as Hero Ecotech Ltd. was technically qualified for only 1 (one) package, the L2 bidder, Hero Cycles Ltd. was offered to match the L1 rate of Rs. 4,019/-. Hero Cycles Ltd. agreed to such proposal.
- 7. In Package 3/3, in terms of ITB 35.1, although Hero Ecotech Ltd. was the L1 bidder with a Financial Bid of Rs. 4,019/-, as Hero Ecotech Ltd. was technically qualified for only 1 (one) package, the L2 bidder, Avon Cycles Ltd. was offered to match the L1 rate of Rs. 4,019/-. Avon Cycles Ltd. agreed to such proposal.
- 8. System generated BOQ chart (comparative statement of rates) in respect of all the three packages were signed by the bidders as well as by the members of the Tender Committee.
- 9. Thus, Package 1/3 was awarded to Hero Ecotech Ltd., Package 2/3 was awarded to Hero Cycles Ltd. and Package 3/3 was awarded to Avon Cycles Ltd.
