1. As per the schedule, the applications of the intending applicants (singly or in consortium) were decrypted, opened and taken up for evaluation.
2. Only 1 applicant, namely, Sarita Agarwal, carrying out business under the name and style of Agarwal Udyog, had participated in the process and submitted its application including sample bicycles.
3. Detailed evaluation of the application made by the applicant was undertaken.
4. Upon evaluation, it was found that the applicant has failed to establish that it has 3 years of experience in manufacturing of bicycles or bicycle components or being manufacturer and assembler of bicycles in West Bengal and that it has failed to submit a valid factory license in this regard. Moreover, the applicant has failed to submit BIS certificates for the frames, forks and mudguards manufactured by it and have failed to submit the Laboratory Test Report pertaining to quality test done by R&D Centre on its bicycles.
5. The detailed Evaluation Report is to be considered as an integral part of the minutes of the meeting.
6. Since the EOI failed to get any local manufacturer, qualifying for supply of bicycles under the Sabooj Sathi scheme, in terms of clauses contained in Bid Reference No. 1413/SCTB dated 03/10/2024 and the present EOI, the Corporation will be at liberty to place supply of the reserve quantity of 1 lakh bicycles on the Selected Bidders of the 2 Packages in Bid Reference No. 1413/SCTB dated 03/10/2024.
