Shri P. Manna – In the Chair

1. Sample bicycles delivered by the bidders were taken up for inspection by Research & Development Centre for Bicycle & Sewing Machine, a joint venture of UNDP & Govt. of Punjab who were engaged for the purpose.
2. Documents submitted by the bidders were taken up simultaneously for evaluation by the Tender Committee.
3. Documents submitted by each of the bidders were checked one by one. Observations of the Tender Committee in respect of each of the parameters were noted in the respective Bid Evaluation Reports. Tender Committee made detailed observations for all parameters on the basis of information submitted by the bidders in forms and documents.
4. From the inspection report submitted by Research & Development Centre for Bicycle & Sewing Machine, it appeared that sample bicycles, both gents and ladies, delivered by the three (3) bidders, Hero Cycles Ltd., Avon Cycles Ltd. and Hero EcoTech Ltd. were in compliance with the technical specifications set by the Corporation.
5. Laboratory Test Report submitted by Hero Cycles Ltd., Avon Cycles Ltd. and Hero EcoTech Ltd. in respect of the sample bicycles were also found in order and in compliance with the requirement of the Corporation.
6. After evaluation, the three (3) bidders, namely, Hero Cycles Ltd., Avon Cycles Ltd. and Hero Ecotech Ltd. were found to have submitted responsive Technical Bids for both packages.
7. Upon considering the manufacturing, financial and bulk supply credentials of the 3 bidders referred to in para 6 above, it was found that the credentials of Hero Cycles Ltd. and Avon Cycles Ltd. meet the requirements for grant of 2 Packages, if selected as

the L1 bidder upon opening and evaluation of the Financial Bids & if situation so arises and Hero EcoTech Ltd. meets the requirements for grant of 1 Package, if selected as the L1 bidder.

8. The detailed Bid Evaluation Reports of Hero Cycles Ltd., Avon Cycles Ltd. and Hero EcoTech Ltd. are to be considered as an integral part of the minutes of the meeting.
9. It was decided that the next meeting of the Tender Committee for Financial Bid Opening and Evaluation would be undertaken on 19-11-2024 at 4 P.M, when the representatives of all the 3 (three) eligible bidders were directed to be present.
