- 2. Financial Bids for Package-1 (1/4) was opened first in terms of ITB 35.1. Rates quoted by the bidders were as follows:-

- 6. Avon Cycles Ltd. was found to be the L1 bidder for Packages 1/4 and 2/4 and thus was declared as the Selected Bidder for the said packages.
- 7. In Packages 3/4 and 4/4, in terms of ITB 35.1, although Avon Cycles Ltd. was the L1 bidder with a Financial Bid of Rs. 3,349/-, as no bidder would be awarded more than 2 packages, the L2 bidder, Hero Cycles Ltd. was offered to match the quote of Rs. 3,349/- offered by the L1 bidder. Hero Cycles Ltd. agreed to such proposal.
- 8. System generated BOQ chart (comparative statement of rates) in respect of all the four packages were signed by the bidders as well as by the members of the Tender Committee.
- 9. In terms of Rule 102 of the Financial Rules as amended by Memo No. 2254-F(Y) dated 24<sup>th</sup> April, 2014 read with Memo No. 925-F (Y) dated 14<sup>th</sup> February, 2017 & its subsequent amendment vide No. 6989-F(Y) dated 19/11/ 2018 and Memo No. 5400-F (Y) dated 25<sup>th</sup> June, 2012, in case of retender, if the number of qualified bidders is two, the Bid Inviting Authority may proceed for opening of Financial Bids and the acceptance of the Financial Bids shall be done with the concurrence of the Finance Department, Government of West Bengal. Therefore, it was decided that prior to issue of Work Order in favour of Avon Cycles Ltd. and Hero Cycles Ltd., concurrence of Financial Department may be sought by Administrative Department.
