Mr. Krishnaswamy of TI Cycles mentioned that specification of seat tube thickness for the boy's cycle should be 1.63 mm instead of 1.22 mm. The point was noted by the Committee. No other prospective bidders, present objected to. The committee declared that the specification shall be changed accordingly by a corrigendum.

Representatives of Manufacturers like SK Bikes, Vishal Cycles, Heroecotech thereafter raised and discussed restrictive qualifying criteria set by the Authority and proposed for relaxation of the same to ensure wider participation and competitive price bid.

Representative of Kohinoor Cycles proposed relaxation in qualifying criteria for Small Scale Units as per the GOI order.

Representative of United Cycles, claimed to have set up manufacturing facility in the State appealed for relaxation as per the State Government's order applicable for SSI.

TI Cycles and Avon Cycles further proposed that in the present Tender the qualifying criteria should have been stricter in view of the fact that a large no. of bicycles will have to be procured within a short span of time.

All the prospective bidders were requested to send their communication, if any by e-mail as mentioned in the Bid document positively by Monday next, i.e. 22/06/2015.

The Committee stated that corrigendum, if there be any, shall be uploaded in the e-procurement portal.
